## Owner's Agreement

I understand all board must be paid monthly in advance and is nonrefundable. Board must be received by the 5<sup>th</sup> day of the month. A \$15 dollar late fee will be charged to board for payments received after the 5<sup>th</sup> day and prior to the 21<sup>st</sup> day. A \$25 dollar late fee will be charged for payments received after the 20<sup>th</sup> day and prior to 31st. If you are 2 or more months behind in board, Mel-O-Dee Stables will have the right to sell the horse. Failure to comply with this or removal of the horse without payment of accrued balance owned shall constitute breach of contract and an automatic lien on the animal in favor of Mel-O-Dee Stables. The horse to my knowledge has not been exposed to any contagious or infectious disease for at least two weeks prior to boarding.

IF you are not able to contact the above veterinarian, I consent to the treatment by the management or stable veterinarian. I understand all the charges will be billed to me. I understand the horse will be treated every 3 months or less for worms at owner's expense. I understand lessons, training, shoeing, hauling, veterinarian services and any miscellaneous expenses are additional costs to myself and will pay them accordingly.

Every precaution is taken to protect the horse from illness, accident, fire and theft. The stable management does not assume the responsibility for any possible accidents, illness, fire, theft or death of horse.

The monthly boarding fee will be \$ \_\_\_\_\_ payable on the 1<sup>st</sup> day of the month. This fee includes normal care and feedings per agreement between horse owner and stable management. Any special care or feeding will be billed accordingly.

A minimum of thirty (30) days notice is required when leaving. Full board must be paid to hold a stall if the animal is taken out temporarily for training, breeding and etcetera.
